The meeting venue must not be lavish e.g., ranking by an internationally
recognized body must not exceed 5 stars.
at least 70% of the guest rooms should be standard types (excluding club access,
pool access, villa, suite, family, duplex room types). Room type naming isn't a
concern

*Note: If for any reason it is necessary to arrange in such place, company should be able to demonstrate that the venue remains appropriate for academic meeting. The venue should not be the main attraction of the event or be perceived as such. The meeting must be based on the subject matter of the meeting rather than the meeting place itself. e.g., the meeting venue focuses on its entertainment, sports, leisure or vacation facilities such as golf club, health spas, water park, amusement parks, or Theme Parks located within the venue or near the venue, or the venue provides such facilities to outsiders; that venue is not considered an appropriate location.
